 - 1. The program has been running since April of 2020. It has been temporarily moved to the Waterloo Board of Education property and currently houses 50 residents.
 - 2. They are registered as a not-for-profit and are in the process of developing their 21/22 budget.
 - 3. Their revenue comes from the shelter allowance (per person), and from various donations.
 - 4. They are experiencing higher than normal construction costs due to their new location move a couple of weeks ago.
 - 5. Not much room to expand in the new location so they have put a hold on new houses. Each one roughly costs 5K.
